PROCEDURES

- Buyer issues an ICPO, LOI, and BCL with right to soft probe. (Includes the NCNDAIMFPA with all the parties involved).
- OJSC OIL COMPANY ROSNEFT issues draft contract initials on every page, signs and seals and send it to the Buyer for Buyer's signature and seal (with amendments if any).
- 5 Buyer counters sign and seals the draft contract and sends via email to the OJSC OIL COMPANY ROSNEFT:
 - Buyer registers the contract with ministry of energy in Charge of registration and transportation of the product to loading port.
 - b. IT IS MANDATORY THAT THE NOTARIZATION AND STAMP DUTIES THAT WILL BE DONE AT MOSCOW HIGH COURT, REGISTRATION OF CONTRACT WITH THE APPROPRIATE AUTHORITIES, THESE EXPENSES WILL BE BORNE BY THE BUYER AND IT IS NOT NEGOTIABLE (67,500 EURO).

SIMULTANEOUS with sending the signed Draft Contract, Buyer's Bank will issue MT799/999 SWIFT Confirmation of 20% proof of funds to Seller's Bank as stated in the DRAFT CONTRACT to enable Seller to move ahead with additional documents.

- 4 OJSC OIL COMPANY ROSNEFT issues original contract for final signatory, both party exchange hard copy of contract via courier. Both parties' lodges' contracts in respective banks.
- OJSC OIL COMPANY ROSNEFT's bank shall notify the Buyer's bank that they are willing and ready to issue a non-operative 2% performance bond (PB) to Buyer's bank. The 2% PB will be placed in Buyer's bank account, should the OJSC OIL COMPANY ROSNEFT fail to supply the cargo of the products, this 2% PB will be paid to the Buyer and intermediaries accordingly as compensation.
- The Buyer issues the DLC for the monthly cargo value within 5 (five) banking days after receipt of 2% PB from the OJSC OIL COMPANY ROSNEFT. This action makes simultaneously and automatically the 2% PB from the OJSC OIL COMPANY ROSNEFT's bank and the DLC from the Buyer's bank operative.
- OJSC OIL COMPANY ROSNEFT's bank issue to Buyer's bank the Proof of Product (POP) providing the following documents as POP (Proof Of products):
 - Copy of license to export, issued by the department of the ministry of energy.
 - b. Copy of approval to export, issued by the department of the ministry of justice.
 - c. Copy of statement of availability of the product.
 - d. Copy of the refinery commitment to produce the product.
 - e. Copy of the OJSC AK TRANSNEFT contract to transport the product to the port.
 - f. Copy of the port storage agreement
 - Copy of the charter party agreement(s) to transport the product to discharge port.
- 8 Within 11 (Eleven) working days OJSC OIL COMPANY ROSNEFT will send Buyer invitation to Russia (Moscow) to view the allocation.
- Delivery commences as per contract and the shipment should arrive at Buyer's discharge port within 50 45 days after the MT 103 receiving by the OJSCOIL COMPANYROSNEFT's bank.
